Thankyou for choosing The cathedral function centre as the venue for your event. To ensure the success of your event, please sign your agreement to the following terms and conditions to accompany your deposit for confirmation of your booking.

BYO: Not Permitted

Confirmation of Booking: bookings are confirmed only when a deposit has been paid

Guaranteed minimum number of guests: the minimum number of guests attending is required 2 working days prior to the event. This will be regarded as the minimum number for catering purposes. From this date numbers may only be increased.

Management reserves the right to charge for this number even if fewer are served. A child is considered to be under the age of 12 years.

Choosing your menu: we ask of you at least 2 working days notice (If Possible) of menus to allow the necessary time and thought to assist you and meet your requirements. Due to seasonal changes our menus may vary.

Function cancellations: cancellations must be notified in writing. Once all the food for the event has been ordered, there is no refund available.

Payment of account: The deposit must be paid 2 days from the date of reservation. Any outstanding amounts can be settled on the day. Whilst endeavouring to maintain all printed prices, they may be vary due to unforeseen circumstances

Damage: clients are financially liable for any damage sustained to the hall and its property including additional cleaning bills.

Responsible Service of Alcohol: Cathedral function Centre upholds the principles of responsible service of alcohol. It is an offence to supply liquor to persons under the age of 18 years. Clients are asked to ensure that underage persons amongst their guests are not supplied with liquor. Our staff reserves the right to request proof of age from any persons suspect to be under 18 years of age. Service will be refused to any persons who show signs of intoxication.
